

RESOLUTION NO. 11-2022

**BOROUGH OF SEVEN VALLEYS
YORK COUNTY, PENNSYLVANIA**

A RESOLUTION OF THE BOROUGH OF SEVEN VALLEYS, YORK COUNTY, PENNSYLVANIA, IMPOSING A 1.20 MILL TAX FOR GENERAL REVENUE PURPOSES UPON ALL REAL PROPERTY SITUATE WITHIN THE BOROUGH FOR CALENDAR YEAR 2023, PROVIDING FOR A DISCOUNT IF PAID WITHIN TWO MONTHS OF THE DATE OF THE TAX NOTICE, PROVIDING A PENALTY FOR FAILURE TO MAKE PAYMENT WITHIN FOUR MONTHS OF THE DATE OF THE TAX NOTICE, AND AUTHORIZING THE TAX COLLECTOR OF THE BOROUGH OF SEVEN VALLEYS TO ISSUE TAX CERTIFICATIONS AND TO CHARGE A FEE FOR THE ISSUANCE OF THE SAME

WHEREAS, The Borough Code authorizes the council of the borough, by ordinance or resolution, to levy and collect annually a tax not to exceed thirty (30) mills for general borough purposes; and

WHEREAS, The Borough Code requires the council of the borough to annually adopt an ordinance or resolution levying the tax for the fiscal year; and

WHEREAS, the borough council deems it to be in the best interests of the citizens of Seven Valleys Borough to impose a 1.20 mill tax for general revenue purposes upon all real property situate within the borough; and

WHEREAS, because the tax rate to be imposed is the same rate or lower than the previous fiscal year, Section 1310.1 of the Borough Code permits the council of the borough to adopt and impose the tax rate by adopting a resolution levying the tax for the fiscal year; and

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Borough of Seven Valleys, and it is hereby resolved and enacted, in lawful session assembled, as follows:

SECTION 1. REAL ESTATE TAX LEVY. A tax for general borough purposes is hereby levied upon all real property situate within the Borough of Seven Valleys, York County, Pennsylvania, for the calendar year 2023 at the rate of 1.20 mills on the dollar on the valuation thereof assessed for county purposes.

SECTION 2. DISCOUNT. All taxpayers subject to the payment of the tax imposed by Section 1., above, shall be entitled to a discount of two percent (2%) from the amount of such tax upon making payment of the whole amount thereof within two (2) months after the date of the notice.

SECTION 3. PENALTY. All taxpayers who shall fail to make payment of the whole amount of the tax imposed by Section 1., above, for four (4) months after the date of the tax notice, shall be charged a penalty of ten percent (10%) of the whole amount thereof.

SECTION 4. TAX COLLECTOR CERTIFICATION. The tax collector or deputy tax collector of the borough is hereby authorized to continue to issue a certification concerning the status of taxes imposed under this resolution or prior ordinances to any person requesting the same and is authorized to charge a fee in the amount of Twenty-Five Dollars (\$25.00) for the certification.


SECTION 5. EFFECTIVE DATE. This Resolution shall become effective immediately upon enactment and approval.


